With graphic pictures and molds illustrating the human brain, they showed how impact and trauma can adversely affect somebody if they are not wearing a helmet when doing activities where there is a risk to head injury.

This was a unique and very well received keynote presentation with a universal topic that applies to everyone, and especially those living with bleeding disorders. After the presentation, each child was fitted was a brand new helmet from Children's. Thank you to Skye, Dex & Children's.

Our child-life programming was led once again by Victoria Neis of Children's Hospitals & Clinics of Minnesota. Vicki and her Team do a terrific job in making it a fun and educational experience for the kids. This year, we also had the pleasure of having child program from Optum, led by PT Angela Forsyth. Thank you to Vicki, Angela, and Optum!

HFMD members love seeing each other in person, and truly enjoy sharing their personal stories with others who can identify with them. So, Roundtable Discussions were next on the agenda where we moved tables together to make 3 large Roundtables with the following topics at each; 1) playing sports with a bleeding disorder, 2) mental health, and 3) pain management. Members shared and learned from each other, as these engaging group discussions are always well received at HFMD events.

After lunch, our group separated into two breakout sessions: Advocacy & Youth Transitioning into adulthood led by Mayo Clinic.

Our Advocacy session featured HFA Public Policy Director, Miriam Goldstein who shared important updates and developments on the federal level. Then from HFMD, Jean O'Connell and I went into to depth on HF 3611 & SF 2136 - state bills to end the Accumulator Adjustor; a highly questionable practice by some health plans where they dismiss 3<sup>rd</sup> party assistance toward patient/family out-of-pocket costs.

HFMD has been working hard at the Minnesota state capitol with support from a collation of other Patient Advocacy groups to get these bills passed into law in 2022. We then had the pleasure to introduce our former and now current lobbyist, Jennifer Breitinger who shared her experience and wisdom with our members, and what they can do to help get these bills passed. Jennifer stressed how impactful letters, phone calls, and emails to your elected officials can be in determining the outcome of a bill.

The Transitioning into Adulthood session featured Dawn Rusk, RN, and Melinda Otto LSW from our Mayo Clinic HTC in Rochester, MN. They put so much thought and preparation into this program which can be so beneficial not only to the teens and youth, but also to the parents and siblings. We are very grateful to Dawn, Melinda, and Mayo Clinic for sharing this very important program at the HFMD Annual Meeting!

Rare diseases are very expensive to treat. There are HFMD families and individuals who rely on 3<sup>rd</sup> party assistance to help offset their high out-of-pocket costs; which for many hit the maximum of \$8,700 for an individual, and \$17,400 for a family each and every year.

Now, some health insurance companies have taken aggressive steps to deny families from using out-of-pocket assistance intended to help them, including assistance from the medication manufacturer. Some HFMD members have been stunned to find out they still owe money that has already been collected but NOT applied to their maximum out-of-pocket cost calculation. This clause in some insurance policies is known as the Accumulator Adjustor.

It is wrong.., it is misguided.., it is harmful to families.., and it should be banned in Minnesota!



#### What is HEMLIBRA?

HEMLIBRA is a prescription medicine used for routine prophylaxis to prevent or reduce the frequency of bleeding episodes in adults and children, ages newborn and older, with hemophilia A with or without factor VIII inhibitors.

What is the most important information I should know about HEMLIBRA?

HEMLIBRA increases the potential for your blood to clot. People who use activated prothrombin complex concentrate (aPCC; Feiba®) to treat breakthrough bleeds while taking HEMLIBRA may be at risk of serious side effects related to blood clots.

These serious side effects include:

- . Thrombotic microangiopathy (TMA), a condition involving blood clots and injury to small blood vessels that may cause harm to your kidneys, brain, and other organs
- Blood clots (thrombotic events), which may form in blood vessels in your arm, leg, lung, or head

#### Medication Guide HEMLIBRA® (hem-lee-bruh) (emicizumab-kxwh) injection, for subcutaneous use

#### What is the most important information I should know about HEMLIBRA?

HEMLIBRA increases the potential for your blood to clot.
Carefully follow your healthcare provider's instructions regarding when to use an on-demand bypassing agent or factor VIII (FVIII) and the recommended dose and schedule to use for breakthrough bleed treatment.

HEMLIBRA may cause the following serious side effects when used with activated prothrombin complex concentrate (aPCC; FEIBA\*), including:

- Thrombotic microangiopathy (TMA). This is a condition involving blood clots and injury to small blood vessels that may cause harm to your kidneys, brain, and other organs. Get medical help right away if you have any of the following signs or symptoms during or after treatment with HEMLIBRA
  - confusion
- stomach (abdomen)
- weakness
- or back pain - nausea or vomiting
- swelling of arms and legs
- feeling sick
- yellowing of skin and eyes
- decreased urination
- Blood clots (thrombotic events). Blood clots may form in blood vessels in your arm, leg, lung, or head. Get medical help right away if you have any of these signs or symptoms of blood clots during or after treatment with HEMLIBRA
  - swelling in arms or legs pain or redness in your
- cough up blood
  feel faint
- arms or legs shortness of breath
- beadache - numbness in your face
- chest pain or tightness
- eye pain or swelling
- fast heart rate

If aPCC (FEIBA") is needed, talk to your healthcare provider in case you feel you need more than 100 U/kg of aPCC (FEIBA")

Your body may make antibodies against HEMLIBRA, which may stop HEMLIBRA from working properly. Contact your healthcare provider immediately if you notice that HEMLIBRA has stopped working for you (eg, increase in bleeds).

#### What is HEMLIBRA?

HEMLIBRA is a prescription medicine used for routine prophylaxis to prevent or reduce the frequency of bleeding episodes in adults and children, ages newborn and older, with hemophilia A with or without factor VIII inhibitors.

Hemophilia A is a bleeding condition people can be born with where a missing or faulty blood clotting factor (factor VIII) prevents blood from clotting normally.

HEMLIBRA is a therapeutic antibody that bridges clotting factors to help your blood clot.

### Before using HEMLIBRA, tell your healthcare provider about all of your medical conditions, including if you:

- are pregnant or plan to become pregnant. It is not known if HEMLIBRA may harm your unborn baby. Females who are able to become pregnant should use birth control (contraception) during treatment with HEMLIBRA
- are breastfeeding or plan to breastfeed. It is not known if HEMLIBRA passes into your breast milk

Tell your healthcare provider about all the medicines you take, including prescription medicines, over-the-counter medicines, vitamins, or herbal supplements. Keep a list of them to show your healthcare provider and pharmacist when you get a new medicine.

#### How should I use HEMLIBRA?

See the detailed "Instructions for Use" that comes with your HEMLIBRA for information on how to prepare and inject a dose of HEMLIBRA, and how to properly throw away (dispose of) used needles and syringes.

- Use HEMLIBRA exactly as prescribed by your healthcare
- Stop (discontinue) prophylactic use of bypassing agents the day before starting HEMLIBRA prophylaxis.
   You may continue prophylactic use of FVIII for the first week of HEMLIBRA prophylaxis.
- HEMLIBRA is given as an injection under your skin (subcutaneous injection) by you or a caregiver.

- Your healthcare provider should show you or your caregiver how to prepare, measure, and inject your dose of HEMUBRA before you inject yourself for the first time.
- Do not attempt to inject yourself or another person unless you have been taught how to do so by a healthcare provider.
- Your healthcare provider will prescribe your dose based on your weight. If your weight changes, tell your healthcare provider. You will receive HEMLIBRA 1 time a week for the first four
- weeks. Then you will receive a maintenance dose as prescribed by your healthcare provider. If you miss a dose of HEMLIBRA on your scheduled day, you
- should give the dose as soon as you remember. You must give the missed dose as soon as possible before the next scheduled dose, and then continue with your normal dosing schedule. Do not give two doses on the same day to make up for a missed dose.
- HEMLIBRA may interfere with laboratory tests that measure how well your blood is clotting and may cause a false reading. Talk to your healthcare provider about how this may affect your care.

#### What are the possible side effects of HEMLIBRA?

See "What is the most important information I should know about HEMLIBRA?"

#### The most common side effects of HEMLIBRA include:

- redness, tenderness, warmth, or itching at the site of injection
- headache
- joint pain

These are not all of the possible side effects of HEMLIBRA.

Call your doctor for medical advice about side effects. You may report side effects to FDA at 1-800-FDA-1088.

#### How should I store HEMLIBRA?

- Store HEMLIBRA in the refrigerator at 36°F to 46°F (2°C to 8°C). Do not freeze
- Store HEMLIBRA in the original carton to protect the vials from light.
- Do not shake HEMLIBRA
- If needed, unopened vials of HEMLIBRA can be stored out of the refrigerator and then returned to the refrigerator. HEMLIBRA should not be stored out of the refrigerator for more than a total of 7 days or at a temperature greater than 86°F (30°C). After HEMLIBRA is transferred from the vial to the syringe, HEMLIBRA should be used right away.
- Throw away (dispose of) any unused HEMLIBRA left in the vial.

#### Keep HEMLIBRA and all medicines out of the reach of children.

#### General information about the safe and effective use of HEMLIBRA.

Medicines are sometimes prescribed for purposes other than those listed in a Medication Guide. Do not use HEMLIBRA for a condition for which it was not prescribed. Do not give HEMLIBRA to other people, even if they have the same symptoms that you have. It may harm them, You can ask your pharmacist or healthcare provider for information about HEMLIBRA that is written for health professionals

#### **BLEEDING DISORDER CAMP**



We are excited to announce registration is now open for Summer Camp! Check out the great information below on how to register for camp.

The Hemophilia Foundation of Minnesota/Dakotas is Collaborating with YMCA Camp Iduhapi this summer to host a six day traditional camp experience for campers who have hemophilia and other chronic bleeding disorders. The mission of camp is to foster community among bleeding disorder patients and promote transition to independence. Campers will enjoy all of the fun of an outdoor summer camp while in a medically-safe environment.

Who Can Attend: Any child, age 8-17, who has hemophilia or another chronic bleeding disorder.

Dates: Sunday, June 19 – Friday, June 24.

Cost: The cost of camp (\$715/camper) is covered by the Hemophilia Foundation of Minnesota and the Dakotas. During registration you will be prompted to enter a coupon code in order to reflect this coverage at check-out. The coupon code is —HEMOPHILIA.

Staff: Our highly trained, skilled, and energetic Camp Ihduhapi staff provide a week full of fun traditional camp activities. They are supported during the week by medical professional volunteers who provide bleeding disorder education and medical support. Accommodations: Campers spend their session with two counselors and a group of other campers in a cabin group. Campers are assigned to their cabin based on age and gender. All food is provided (including options for allergies and other dietary requirements). Hemophilia Camp is peanut- and shellfish-free.

Transportation: Drop off (Sunday) and pick up (Friday) is at YMCA Camp Induhapi in Loretto (30 minutes west of the Twin Cities). Transportation is not provided.
