Hemophilia treatment center updates were shared followed by Nancy Saslow, Integrative Therapist, who spoke to us about Integrative Therapies for Easing the Stress of Bleeding Disorders. We learned how to calm ourselves using breathing, pressure points, and received handouts so we can practice at home. Dr. Pruthi presented on Heart Disease in Persons with Bleeding Disorders and discussed the risk factors that we all face as we age. Saturday after a build your own sandwich lunch we were led in Yoga by Nancy Saslow. Again, we had participation by young and old.



The afternoon and evening many enjoyed the lazy river and slides in Chaos Water Park and the laser tag, indoor go carts and arcade games at Action City.

# 2012 HFMD Scholarship Applications



The Hemophilia Foundation is accepting scholarship applications for post-secondary education from now until June 1st. Forms are available on line at www.hfmd.org or by calling the HFMD office at 651-406-8655 or 1-800-994-4363.

Scholarship eligibility requirements for applicants include (1) having an inherited bleeding disorder, (2) being a resident of Minnesota, North Dakota or South Dakota, or being a patient of one of the Hemophilia Treatment Centers in these states, and be a participant in HFMD programs and services, and (3) be accepted into a post-secondary educational program.



We were also honored to have Ms. Lauren Gilchrist, Special Advisor (health care) from the Governor's Office to present and answer


